Under the 2017 law your federal taxable income is reduced by \$12,700 (standard deduction) and \$12,150 (personal exemptions) for a new taxable income of \$45,150 (\$70,000 – \$12,700 – \$12,150). Under the new law your \$70,000 income would only be reduced by \$24,000 for a new total of \$46,000. So, this family is worse off!

## ~~What the New Tax Law Means for Family Child Care – Tom ...~~

Working parents of children who will be aged below four years on 31 August 2017 can apply through the new digital childcare service for Tax-Free Childcare – and will receive a government top-up of £ 2 for every £ 8 that they pay into their Tax-Free Childcare account.
